The terms of this order cannot be changed by agreement of the parties. Only the court can change this order.

You shall enforce this order even if there is no record of it in the Restraining Order Central Registry. You shall take the restrained person to the nearest jail or detention facility. You are authorized to use every reasonable effort to protect the alleged victim and the alleged victim's children to prevent further violence. You may transport, or arrange transportation to a shelter for the alleged victim and/or the alleged victim's children.
